

Terms and conditions
HSBC Amanah's Trade package for SMEs

2. This Promotion is organised by HSBC Amanah Malaysia Berhad (Company No. 807705-X) ("HSBC Amanah").
3. An eligible customer who meets the qualifying conditions in clause 4 below will get to enjoy preferential rates on charges/fees for any of the following HSBC Amanah trade products and services ("Promotional Products") :-
