Amended Terms and conditions – HSBC March School Holiday Promotion (“This Promotion”) effective from 1 March 2010

A. This amended Terms and Conditions for "HSBC March School Holiday Promotion" ("this Terms and Conditions") will take effect from 1 March 2010. Eligible Cardholders who only participated in this Promotion from 1-28 February 2010 (“these Eligible Cardholders”) will be governed by the existing, pre-amended Terms and Conditions for “HSBC March School Holiday” Promotion.

B. For easy reference, the amendments to this Terms and Conditions are in bold and underlined as below.

1. This Promotion is from 1 February 2010 to 31 March 2010, both dates inclusive (**“Promotion Period”**).
2. This Promotion is open to all HSBC Bank Malaysia Berhad (“HSBC”) Credit Cardholders, EXCEPT for the following categories of persons:
 - (a) Holder(s) of HSBC Credit Cards that are not issued in Malaysia; and/or
 - (b) Holder(s) of invalid or cancelled HSBC Credit Cards and/or whose accounts are delinquent within HSBC’s definition at any time during the Promotion Period; and/or
 - (c) Holder(s) of company and / or corporate HSBC Bank Credit Cards; and /or
 - (d) Holder(s) of “5000” and /or “9000” series HSBC Bank Credit Cards

(hereinafter referred to as the **“Eligible Cardholder”**).

3. Registration Criteria:

- (a) To participate in this Promotion, the Eligible Cardholder must first register any one of his/her Participating HSBC Bank Credit Card number(s) via SMS during the Programme Period. Registration process is as follows: SMS HSBC<space>your 16 digit HSBC Bank Credit Card number to 33213. Standard telco charges will apply for each SMS sent.
- (b) Upon successful registration, the Eligible Cardholder will receive a confirmation via SMS. Such confirmation will be sent to the mobile number used for the registration as stated in clause 3(a) above and the confirmation SMS will cost the Eligible Cardholder RM0.30.

4. An Eligible Cardholder who makes an eligible spend as per clause 5 below stands to win a movie pass to 'Alice in Wonderland' or any other movie distributed by Buena Vista Columbia TriStar as stated under clause 7 (m) below, subject to fulfillment of the qualifying conditions within the Promotion Period, while stocks last and on a first-come, first-served basis.

(herein referred to as "Prize")

5. Qualifying Conditions:

- (a) Every seven (7) swipes (minimum spend of RM50 for each swipe) on any of the Eligible Cardholder's Participating HSBC Credit Card by the Eligible Cardholder and/or his/her supplementary credit cardholder(s) for each of the participating months of February 2010 (i.e. 1-28 February 2010) and March 2010 (i.e. 1-31 March 2010) respectively ("each Participating Month") within the Promotion Period may entitle the primary Eligible Cardholder to receive one (1) unit of the Prize.

 - (k) Vouchers is valid from 1st Feb 2010 till 30th June 2010
 - (l) The voucher is not a movie ticket and does not permit entry to any GSC cinemas
 - (m) The movie pass can be redeemed for the following movies only:

8. The Prize is provided on an “As Is” basis, while stocks last and on a first-come, first-served basis.
9. In the event of unavailability of the Prize, HSBC reserves the right to substitute the Prize with any other prize of similar value at any time **with 3 days** prior notice.
10. HSBC reserves the right, at its absolute discretion, in the allocation of the Prize to the Eligible Cardholders and no request by the Eligible Cardholder or any other party for the exchange or substitution of any Prize with another Prize for this Promotion will be entertained.

2. This Promotion is open to holders of HSBC Premier MasterCard Credit Card, HSBC Visa Platinum credit card, HSBC Gold MasterCard credit card, HSBC Visa Gold credit card, HSBC Visa Classic credit card and HSBC Classic MasterCard credit card only ('Participating HSBC credit cards'); except for the following categories of persons:
 - a) Holder(s) of HSBC credit cards that are not issued in Malaysia; and/or

3. This promotion
