

HSBC Wealth Management Promotion Terms & Conditions

1. The HSBC Bank Malaysia Berhad (“HSBC”) Wealth Management Promotion (“Promotion”) will run from 12th May 2008 to 31st July 2008 (both dates inclusive) (“Promotion Period”).
2. This Promotion is open to selected existing HSBC customers who are issued the Direct Mailer Invitation to participate in this Promotion. (“hereinafter referred to as the “Eligible Participant”).
3. Eligible transaction criteria for this Promotion:
To qualify for this Promotion, the Eligible Participant must satisfy the following requirements:
 - a) The Eligible Participant must invest a minimum of RM250,000 in one single product or combination of products of either Bond Fund, Equity Fund, Capital Protected Fund, and/or Structured Investment Products distributed by HSBC within the Promotion Period. The above investment(s) must be transacted by 31 July 2008.
 - b) The Eligible Participant who satisfy the requirements in clause 3a) above will stand to receive the following Gift:
 - i) A bottle of Moet Chandon Champagne (for non-Muslim Eligible Participant) or

 - e) In the event of unavailability of the Gifts, HSBC reserves the right to substitute the Gifts with any other item of similar value at any time without prior notice.
